




## Who We Are

- Phase One is finished and Phase Two will start in Fall.







## Trash Abatement - Accomplishments

#### Our Business Stinks, but it's Picking up

- Picked up over a thousand pounds of trash from the curbs, sidewalks, parking lots, and parks along the streets in Friendship Heights (MD & DC) and on Little Falls Parkway and River Road.
- Persuaded local businesses to improve cleaning up trash from the areas around their premises, notably:
  - Mazza Gallerie
  - Lord & Taylor
  - Washington Real Estate Investment Trust
  - (Booeymonger's, TJ MAX, etc.)
  - JBG/Chase Tower (Chipotle, Panera, etc.)
  - Enterprise Rent-A-Car
  - 7-Eleven
- Testified in favor of the newly adopted MC bag law.
- Submitted detailed comments on implementation of the new MC Municipal Separate Storm Sewer System (MS4) permit; our extensive trash comments were endorsed and incorporated by reference in the MC Stormwater Partners' comments.
- Lobbied county officials to strengthen the enforcement and scope of solid waste laws.
- For DC's Advisory Neighborhood Commission 3E (AU Park, Tenleytown, Friendship Heights), developed a database of commercial property owners in the upper Wisconsin Avenue corridor, and used it to mail letters to 130 businesses notifying them of DC public space cleaning requirements.



# Why Care About Trash?

- LFWA's philosophy: Stop trash at its source, BEFORE it can enter our waterways.
- Trash left on the ground creates a host of ills, including blighting the neighborhood, lowering property values, and damaging the environment. Rainwater washes it into storm drains that empty into the Little Falls creek, and eventually farther downstream into the Potomac River and the Chesapeake Bay.
- When it enters our waterways, trash destroys wetlands -the cradle of life on earth -- by interfering with the establishment of emergent aquatic plants, is hazardous to wildlife through ingestion and entanglement, and releases toxins as it decomposes in the water.



## Trash Resolutions for 2012

- 1. I will dispose of trash and pet waste in a proper receptacle.
- 2. I will educate my children to do the same.
- 3. I will pick up at least 5 pieces of trash each day that I walk in the neighborhood.
- 4. I will "adopt" a street block near my home and strive to keep it trash free.
- 5. I will educate myself about which materials are recyclable and deposit them in the appropriate blue recycling can.
- 6. I will bind or contain loose papers before I put them in the blue recycling can, and bag garbage before placing it in my trash can, so as to minimize the chance of spillage upon collection by sanitation workers. I will clean up any spillage that does occur.
- 7. I will pick up from in front of my home any newspapers delivered there, and I will contact the circulation department of any newspaper that I do not wish to receive to cancel delivery.
- 8. I will volunteer to participate in organized trash pick-ups.
- 9. I will call 311 to report violations of the Montgomery County Code provisions that require businesses to keep their parking lots and other grounds free of trash.
- 10. I will make sure that trash is picked up before mowing my lawn.
