## Norwood Park Meadow Project

- Restoration of ¼ acre meadow at the end of Norwood Park
- Partnership with Montgomery Parks
- Funded in part by a grant from Whole Foods
- Phase One: Clearing finished
- Phase Two: Planting over
  500 plants this fall –
  Community Work Day:
  November 1
- Phase Three: Spring planting

## LFSVP Deer Exclosures

- Built and maintain three deer exclosures in the lower part of Little Falls Stream Valley Park as part of a study on restoring native plants and impact of deer population.
- Exclosures create control areas to assess impact of deer grazing.
- Partnership with Montgomery Parks
- Non-native invasives have been removed from exclosures
- Each exclosure has a dedicated weed warrior volunteer.
- Native plants will be introduced next year after the soil has rested and native seeds have had a chance to re-establish themselves.



# **SHA** Highway Restoration

- Partnered with State Highway Administration to remove nonnative invasives from the Massachusetts Avenue entrance to the Little Falls Stream Valley Park.
- Hosted community planting days to plant redbuds, hollies and other native shrubs.
- Work with community members to water and maintain new plants
- Installed deer fencing around shrubs.



# Little Falls Watershed Restoration and Stormwater Management Effort

- Involved with Montgomery County's new watershed restoration initiative to improve stormwater management (MS4 permit requirement) in the Little Falls watershed and improve the health of the stream and other local waters.
- Attend public meetings including
  - DEP public outreach meeting in February 2014 in Potomac, MD
  - Attended the Little Falls Library project meeting in May 2014



- Attend WSSC meetings on sewer improvement project in the Little Falls Basin.
- Accompanied DEP scientists when they conducted stream-monitoring of the creek in April 2014
- Work with Town of Somerset residents on neighborhood initiative to build rain gardens and other conservation landscaping
- Participate in County effort to mentor local watershed groups to help achieve MS4 goals. Attend meetings and workshops with County personnel as part of mentoring program.



## Advocacy and Education

- Member of Save Ten Mile Creek coalition and testified on behalf of the environment. Successfully lobbied Montgomery County Council to limit building in this fragile watershed.
- Monitoring EYA townhouses to make sure they adhere to environmental protection regulations.
- Working with coalition to monitor Westbard development.



- Working with Montgomery Parks and citizens to study deer problem in the park.
- Educate members on environmental issues through monthly e-letter and community list serv notices. Monthly newsletter goes out to 1,300 members. List servs reach over 10.000 watershed residents.
- Members of Stormwater Partners, Coalition for Clean Water and other regional environmental groups.
- Report illegal dumping, erosion violations and other threats to the health of the creek.
