

2020: A Year Like None Other

2020 started out a high note. We hosted our first ever First Day Hike and 80 joined us for a 5-mile round trip hike to the mouth of the Little Falls Branch on the Potomac River. We partnered with a group in Palisades to start a new habitat restoration project and March looked promising with a well attended trash pick-up and more weed removal days.

Everything came to a halt that month because of the Pandemic. Community work days were cancelled and meetings and outdoor gatherings were prohibited. Our President, Jack Sobel, sent out a heartfelt message explaining why we were cancelling our events for the foreseeable future.

However, as the understanding of the virus progressed and the need for outdoor activities became paramount, our board rallied and with strict adherence to CDC guidelines, we resumed our trash pick-ups and habitat restoration work. We hosted 36 "individual trash pick-ups"; two eagle scout projects and several small group habitat restoration days. Over 500 volunteers joined us in these activities.

2020 was also an interesting year for advocacy and testimony. Shortly after our March testimony in Annapolis to support State monies for building the new Willett Branch Park, all in-person public meetings were cancelled. We learned to Zoom and how to have virtual meetings and our advocacy continued. We are proud to announce that Maryland did approve monies for the new Park. We have also continued our advocacy for strictest stormwater management for new development in Westbard and were pleased to learn that the new road planned for Westbard will have 100% stormwater management. The concrete storm drain on Little Falls Parkway was finally was replaced with a vegetative swale, another win for the environment.

Other highlights of 2020 include welcoming three new board members, starting a bacterial monitoring program and our most successful fundraising year. Thank you to everyone for making this possible.



Little Falls Watershed Alliance

- Little Falls Watershed Alliance is an environmental stewardship group, founded in 2008 by a group of neighbors committed to protecting the fragile natural environment of the Little Falls and Willett Branches and surrounding Little Falls watershed. Our mission is to ensure that the natural spaces in our area persist for generations to come. We strive to bring neighbors together in order to build awareness, improve the natural habitat, protect our community's natural heritage, and enhance the community's enjoyment of our creeks and wooded areas.
- From our first meeting, we have grown to over 2,800 members and engaged more than 6,500 volunteers in over 600 work days and other activities. Our volunteers have logged over 17,000 hours of service to the watershed.
- As stewards, we are committed to restoring the water quality, natural habitat and ecological well-being of the Little Falls Watershed. We focus on trash abatement, habitat restoration, and stormwater management.
- As advocates, we speak up for the needs of our parks and natural areas, and we advocate for clean water laws that are fair and enforced consistently.
- As educators, we work with neighbors, school groups, local businesses and other community members to educate through classroom activities, festivals, community work days and outreach events.




Trash Removal





- Partnership with Montgomery Parks and Montgomery County DOT. We provide volunteers with boots, gloves and bags.
- Hosted Individual Trash Pick-ups after the Pandemic cancelled group work days.
- Bags and gloves at two stations every Saturday starting in June.
- □ 522 volunteers; 980 man hours
- 7,020 pounds of trash; 42 bags of recyclables




Invasive Weed Removal

- Before Pandemic, hosted 4 community work days January through March - 64 participants, 128 man hours.
- After Pandemic, hosted two Eagle Projects and 6 small group work days June – December to remove invasives.
- Partnered with Montgomery County Public Schools to work in Forest Conservation areas and with Montgomery Parks.

Norwood Meadow

- Installed in 2011 in partnership with Montgomery Parks, funded in part by a grant from Whole Foods
- First meadow installed in a County park outside of Brookside Gardens.
- Ten community planting days have installed over 3,000 native grasses and wildflowers.
- Reseeded with wildflower seeds gathered from Montgomery County plants.









Westbrook ES Meadow

- Partnership with Montgomery Parks and Westbrook Elementary School (MCPS).
- Students from the elementary school grew trees and plants from seeds.
- Local neighbors maintain meadow.
- In twelfth year.







Stewardship - Habitat Restoration

Green Acres Meadow

Neighborhood led; Partnership with Department of Transportation.

Phase Two completed: Land cleared and 200 native wild flowers and grasses planted with help of community members and local Elementary School Environmental club.

Phase Three completed: 15 trees and shrubs planted along the creek bank in partnership with DOT.







Creek Monitoring

Benthic Macro-Invertebrate Monitoring:

- Monitor Little Falls Branch four times a year
- 13 person teamed trained to capture and identify macro-invertebrates living on the bottom of the creek.
- Report data to partner Audubon Naturalist Society

Salt Level Monitoring:


- Test salt level in four locations as part of national study on impact of road salt on waterways.
- Data is reported to Isaac Walton League












Creek Monitoring

Bacterial Monitoring

- Piloted a program in Fall to sample the Little Falls and Willett Branches to test for turbidity and bacterial count.
- Sampled 3 locations on the Little Falls Branch and 2 locations on the Willett Branch
- Hoping to determine fecal bacterial load and effect of WSSC sewer repair on the streams.

Stewardship - Stormwater Management

Sumner Village Grant - Completed

Stormwater Management Project



- Worked with Sumner Village Homeowners Association to install green stormwater management to address serve erosion and flooding caused by run-off from uphill properties.
- Awarded a \$20,000 grant in 2019 to install project. Funding for the grant is from the Montgomery County Water Quality Protection Fund.
- Project includes dry creek, dry well and native planting.
- Project was completed in Fall 2020 with a small show and tell event.









Education and Outreach First Day Hike

- For 2020, we decided to join the First Day hike movement and host a 5-mile round trip hike from Little Falls Park Mass. Ave entrance to the mouth of the Little Falls Branch on the Potomac.
- Board Members led the hike and answered questions along the way.
- Great success 80 people participated.









Education and Outreach

Social Media, Community Events

- Publish monthly e-newsletter with information on environmental issues, native plants and events of interest.
 Newsletter is sent to 2,800 people on our mailing list.
- Speak to local garden clubs on issues facing the watershed

Advocacy

Willett Branch; Stormwater Management

Willett Branch Greenway

Since 2015, LFWA has been advocating for the formation of the Willett Branch Greenway, a new park and naturalized stream to replace the graffiti covered concrete culvert that is the current Willett Branch. The focus of much of our advocacy has been to ensure that development in the area of the new park conforms to the strictest stormwater management regulations. 2020 was an important year as the first parcel along the new greenway was approved as well as the new road for the development. Our work included submitting comments and testifying for strong stormwater management for the new building and road. We are proud to report that building will have 100% green stormwater management and the new road will be treated with a combination of green and structural methods, but with no need for a waiver.

Stormwater Partners

LFWA is a member of Stormwater Partners, an advocacy group for stormwater management regulations in Montgomery County. As a member of the group, LFWA has been involved in writing comments on the new stormwater (MS4) permit for both Maryland and for Montgomery County, advocating for implementation of a "no waiver" policy for stormwater management permits for new construction.

LFWA is also a member of the **Chose Clean Water Coalition**, **Montgomery Conservancy**, and **Trash-Free Maryland** and participates in their advocacy campaigns.
